**STATEMENT ON SAFETY FROM THE NOTICE OF RACE:**

**General.** The safety of a boat and her entire management including insurance shall be the sole responsibility of the owner/person in charge who must ensure that the boat and crew are adequate to face the conditions that may arise in the course of a race. Neither these sailing instructions nor any inspection of the boat limits or reduce the absolute responsibility of the owner/person in charge for the crew, the boat and her management. The race organisers shall not be responsible for any loss, damage, death or personal injury howsoever caused to the owner/person in charge or crew, as a result of their taking part in the race or races. Moreover, every owner/person in charge warrants the suitability of the boat for the race or races. It shall be the sole responsibility of competitors to decide whether or not to start, or continue to race. Boats must carry the minimum safety equipment required by POFSA where this is in excess of class requirements.

**Personal Buoyancy.** Competitors in dinghy classes and all competitors under the age of 18 shall wear approved buoyancy aids whilst afloat. Wet or Dry Suits are not adequate.

**Rendering Assistance.** If any boat is in serious difficulty and requires assistance, the nearest boat is expected to stand by and assist if possible until the arrival of a safety boat.

**Insurance.** Members taking part in club racing must be insured against third party liability for at least £2,000,000, underwritten by an ABI Member Company or Lloyds of London.

**Failure to comply with all the above will constitute grounds for protest and disqualification by the Race Committee.**

**DECLARATION:** I declare that I hold a valid and current boat insurance which covers me for third party claims whilst racing and that I will continue to do so whilst racing in club races. I agree to be bound by the Racing Rules of Sailing and all other rules that govern club races. I have read the statement on Safety and Notice of Race and confirm I agree to be bound by its provisions and that my boat will conform to its requirements whenever racing in club races.
